## Program Overview

- Focus is to reduce congestion, improve throughput and safety on most critical commute corridors
- Per voter approved Expenditure Plan 27.5% of Measure A revenue dedicated for the Highway Program
  - 17.3% for Key Congested Areas (KCA)
  - 10.2% for Supplemental Roadways (SR)

## Project Eligibility

Criteria Category	Detailed Criteria
<b>Description of Eligible Projects</b>	<p>Capital funding for the project development, right of way acquisition and construction of improvements to:</p> <ul style="list-style-type: none"> <li>• 11 identified KCA projects on state Highways 101, 280, 92 and 1</li> <li>• 15 identified SR projects on highways and other roadways from partial list in Expenditure Plan; new projects may be submitted to account for changing needs</li> </ul> <p>Ineligible projects/activities:</p> <ul style="list-style-type: none"> <li>• Maintenance/rehabilitation</li> <li>• Separate pedestrian/bicycle overcrossings</li> </ul>

## Process: Funding & Evaluation

- **Call-for-Projects to be issued May 2015**
  - Covers Fiscal Years 2016 & 2017
  - Up to \$125 million available
  - \$16 million from Original Measure and \$109 million from New Measure
- **Proposals will be evaluated by a panel consisting of TA and external agency staff**

• <b>Policy Consistency &amp; Sustainability:</b>	<b>15%</b>	<b>15%</b>

## Evaluation Criteria: Need & Effectiveness

Evaluation Criteria Category	Detailed Criteria
<b>Need</b>	<ul style="list-style-type: none"> <li>• Current congestion</li> <li>• Projected congestion</li> <li>• Located in a Countywide Transportation Plan Priority Corridor</li> <li>• Identified safety issue</li> </ul>
<b>Effectiveness</b>	<ul style="list-style-type: none"> <li>• Ability to relieve congestion/performance improvement</li> <li>• Ability to address safety issue</li> <li>• Regional significance</li> <li>• Demonstrates coordination with adjacent projects/integration of inter-related projects</li> <li>• Cost effectiveness</li> </ul>

## Evaluation Criteria: Readiness & Funding Leverage

Evaluation Criteria Category	Detailed Criteria
<b>Readiness</b>	<ul style="list-style-type: none"> <li>• Clear and complete proposal</li> <li>• Project status and schedule</li> <li>• Ease and speed of implementation</li> <li>• Results from a public planning process</li> <li>• Demonstrates stakeholder support</li> <li>• Has a solid funding plan</li> </ul>
<b>Funding Leverage</b>	<ul style="list-style-type: none"> <li>• Percent of matching fund contribution</li> <li>• Private sector contribution</li> </ul>

## Evaluation Criteria: Sustainability & Policy Consistency

Prioritization Criteria Category		Detailed Criteria
Sustainability and Policy Consistency	Sustainability	<ul style="list-style-type: none"> <li>• Project is primarily an operational improvement vs. infrastructure expansion</li> <li>• Project accommodates multiple modes, where contextually appropriate and to the extent feasible (Complete Streets)</li> <li>• Supports transit-oriented development</li> <li>• Spurs economic activity/new development in the vicinity</li> <li>• Includes green construction practices and elements</li> </ul>
	Policy Consistency	<ul style="list-style-type: none"> <li>• Project recognized in regional, county or local planning documents</li> </ul>

## Proposed Revisions

- **Sponsors encouraged to coordinate with TA to better ensure sufficient resources and expertise are in place to improve project delivery**
- **Vary weighting for Need & Effectiveness Criteria based on status of environmental clearance**
- **No set aside for KCA planning projects**
- **Resolutions required for all projects**
