<u>Draft Recommendation on Caltrain Governance</u>

Carter Mau, SamTrans General Manager/CEO, presented San Mateo County Transit District's (SMCTD's) "Pathway Forward" Proposal.

Board members had a robust discussion on indemnification, accountability, liability, timeline for repayment, penalties for non-repayment, and how SMCTD reached \$15 million as a compensation amount.

- Issue 2 Appointment and termination process for the Caltrain Executive Director

- Issue 6 Path to Implementation

Chair Heminger appointed Directors Davis, Gee, and himself to a new Governance Ad Hoc Committee that is to meet before the next Caltrain Board meeting (March 3rd) to further discuss the issues on the table, particularly negotiating Issue 5 – payment of interest and/or additional compensation to SMCTD.

He noted that Governance Ad Hoc Committee would consult with Grace Crunican, former General Manager of BART and Federal Transit Administration (FTA) official in Washington.

Monthly Reports

Monthly reports were accepted in written format as part of the packet available online due to the length of the meeting.

Acting Executive Director Michelle Bouchard noted that there would be three weeks of special construction regarding cutovers (with two more in the future) to ensure September 2024 revenue service. This would mean a reduced peak period service to three trains per hour for those three weeks, which would be announced online.
