## Monthly Reports were provided on the following items:

- Report of the Citizens Advisory Committee CAC Brian Shaw, Chair, announced openings for the San Francisco and San Mateo County seats, including reports on ridership increasing, member contribution, Measure RR fees, 15 ride tickets, and state of good repair.
- Report of the Chair Dev Davis provided a report that included recognition of June as Pride month (with a resolution to be presented at the July meeting to be retroactively effective for June) and the progress and future steps on governance process and meetings. She noted that the next Special Board meeting on governance will be on June 25<sup>th</sup> and additional meetings on August 20 and October 22.
- Report of the Executive Director Michelle Bouchard, Acting Executive Director, Support, provided updates on incentivizing riders to return to transit, developing business recovery strategy including fare structure, and attending Blue Ribbon Task force to discuss challenges. She noted that they have 19 nine car electric trains instead of 16 six car electric trains and electrification project benefits including improved performance, reduced emissions, positive economic benefits, and reduced noise.
- Electrification Project (PCEP) Update John Funghi, CalMod Chief Officer, provided detailed updates on construction management efforts, which included the following: increasing costs and schedule delays, PG&E work going well, traction power system design complete, switchgear installation to start in June 2021, the escalating costs to complete the program, and anticipated completion dates for various milestones in the project.
