DISCUSSION HIGHLIGHTS FROM COMMITTEES

Community Relations Committee

Accessible Services Update

Tina Dubost, Manager, Accessible Transit Services, announced that Senior Focus at Sutter Health is closing, which represented approximately 5 percent of paratransit ridership.

Citizens Advisory Committee Update

Director Gee requested that the SamTrans CAC help manage rider expectations regarding school service once the schools reopen. Carter Mau, Deputy General Manager/CEO, said that the District was meeting and working closely with the County Superintendent's office to provide the best service and prioritize service to underserved communities.

Strategic Planning, Development, and Sustainability Committee

<u>SamTrans Adaptation and Resilience Plan Study Findings and Recommendations</u>
Amelia Timbers, Principal Planner, Sustainability, provided a presentation on the study findings. Director Dave Pine said he strongly supported climate analysis as an active approach to track sea level rise. Director Gee said that the City of Redwood City recently approved setting aside funding to study sea level rise.

Legislative Committee

<u>State and Federal Legislative Update</u>

Jessica Epstein, Government and Community Affairs Officer, briefly summarized the highlights of recent federal legislation, which included approval of President Biden's pandemic rescue plan. She said on the state side that more than 2,500 bills were introduced that focus heavily on pandemic relief and response. She noted that there are several items in the budget trailer bill relating to the Transportation Development Act (TDA).
