 - o Planned weekend shutdown in various areas
 - In light of the recent storms, plans for clean up and working with cities along the corridor to prevent trees falling on the tracks
 - o Martin Luther King Jr. celebration train with 500 people attending
- African American History Month Resolution Tasha Bartholomew, Communications Manager, provided the resolution. She cited a 2020 survey that showed African Americans make up 8 percent of Caltrain's ridership, and of those surveyed, 52 percent of African American riders take Caltrain four or more days a week
- Authorized Award of Contract to and Authorize Execution of Agreement with Compass in Connection with Bus Bridge Services for the Caltrain Peninsula Corridor Electrification

Project (PCEP) 2023 Bus Bridge Services - Pranaya Shrestha, CalMod Chief Officer, spoke about the bus bridge contract and the need for Caltrain to implement 31 weekend area shutdowns in 2023 for electrified service.

- Amended Balanced Budget and Financial Reserve Policy to Allow for Biennial Budgets Ladi Millard Olmeda, Director of Budgets Administration, spoke about adopting a biennial budget effective Fiscal Year 2024-2025. Advantages of the biennial budgets included syncing budgets cycle with two out of three member agencies, planning for funding commitments and having a two- year look ahead regarding member agency contributions. In response to Board questions and request, staff will check with the third partner agency to see if they would also consider having the same budget cycle as the other two partners.

 New Starts process, upcoming DTX milestones, Master Cooperative Agreement (MCA),
 and received feedback on draft negotiating principles to inform Caltrain's approach to
 the MCA
- Peninsula Corridor Electrification Project (PCEP): Monthly Progress Report and Update on 2023 Construction and Service Impact Plan — Pranaya Shrestha, CalMod Chief Officer, provided the following information:

 - Safety and security with no reportable injuries and top risk being the overhead catenary system installation delay due to low contractor productivity
