Board Actions

Board Highlights

- Director Jeff Gee reported on behalf of the Board Nominating Committee that the public member recruitment period would be extended 30 days to increase the pool of potential candidates.
- April Chan, General Manager/CEO, noted that MTC's (Metropolitan Transportation Commission) Clipper START program would be brought to the Board at a future meeting to discuss extending the program, which offers a 50 percent fare discount to eligible riders.

Committee Discussion Highlights

Community Relations Committee

Monthly Performance Report | March 2023

Ana Rivas, Director of Bus Transportation, noted that there was only one DNO (Did Not Operate) for the month of March. She said that although the number of preventable accidents had increased, those accidents involved no injuries and were the result of vehicles making contact with immovable objects and not maintaining an adequate space cushion. She added the operator training is in place to address these preventable accidents.

Finance Committee

Award of Contract for Interim Hydrogen Fueling Services

Award of Contract for the North Base Facility Modifications for FCEBs

Liria Larano, Deputy Chief, Bus Fleet and Facilities, provided the presentation on fuel cell electric buses (FCEB) and their maintenance and infrastructure. The Directors expressed concern that only one contractor had submitted a proposal for each of the contracts for the FCEB infrastructure and facility modifications. Ms. Larano said that despite extensive outreach, the market was very busy and they did not receive additional proposals. She added that both contractors had been thoroughly vetted to perform the work.

Approve Establishment of an Account in the California Employers' Pension Prefunding Trust Program

Doug Pryor, Actuary, Bartel Associates, LLC, provided a presentation on the 115 pension trust. In response to Directors' questions regarding the advantages of an irrevocable trust, Mr. Pryor said a revocable trust would be subject to the investment requirements of the District. He explained that if the 115 trust is not used, the money could be used for other purposes than benefits.

Legislative Committee

<u>State and Federal Legislative Update and Approval of Legislative Proposal: Support Assembly Bill</u> (AB) 557 (Hart)

Jessica Epstein, Manager, Government and Community Affairs, provided an update on recent federal and state legislation. At the federal level, she said the House and Senate have been arranging appropriation committees. At the state level, she said the legislature had reconvened following their recess. Ms. Epstein noted that they are seeking Board support AB 557, which would codify AB 361 to increase the flexibility of agencies to meet remotely during designated states of emergency. She also noted that AB 817 had become a two-year bill and that there were two AV (autonomous vehicle) bills which will affect how transit agencies can incorporate AV technology and that impact collective bargaining units.
