On behalf of the San Mateo County Transportation Authority (TA), I write in support of the City/County Association of Governments of San Mateo County's (C/CAG) application for Rebuilding American Infrastructure with Sustainability and Equity (RAISE) Grant Program funding (for Fiscal Year 2024) for its San Mateo County Pathways Forward: An Inclusive Bike and Pedestrian Plan (Project).

C/CAG is seeking RAISE funding to fund this planning Project, which will promote walking and bicycling through infrastructure and programmatic improvements, such as increasing the connectivity and expanding the network of bicycle and pedestrian facilities for a diverse population in San Mateo County. Projects identified in the Plan intend to reduce air pollution and promote a healthy lifestyle.

With newer mobility options like e-bikes becoming more available, this Plan also aims to identify facilities and infrastructure (charging stations) to facilitate longer distance bike travel and recreation opportunities along the San Mateo County coast. Integrating technologies such as drones and artificial intelligence for sidewalk inventory will mark the initial phase of assessing deficiencies within the infrastructure.

This evaluation will inform targeted investments to close gaps and enhance accessibility, as sidewalks are a cornerstone of inclusive and accessible transportation. Additionally, this Plan will focus on identifying historically underserved communities in the County and will enable C/CAG and partner agencies to create places where residents and visitors can walk and bike safely regardless of age or ability, in line with RAISE program goals.
