Multimodal Ridership Report-September 2020

comprehensive evaluation of the program in January, which they would present to the Board in February.

Seamus Murphy, Chief Communications Officer, confirmed that MTC (Metropolitan Transportation Commission would approve the resolution as part of their latest regional strategy.

Millie Tolleson, Principal Planner, said that people could start applying for Clipper START now before the program begins in January. Chair Matsumoto suggested various options for promoting registration in the program.

Committee Chair Dave Pine said that the 50 percent discount level would be a boon to many riders.
