1) CALL TO ORDER/PLEDGE OF ALLEGIANCE

Vice Chair John Fox called the meeting to order at 4:32 pm and led the Pledge of Allegiance.

2) ROLL CALL

CAC Secretary Jean Brook called the roll. A quorum was present.

3) APPROVAL OF MINUTES OF THE TA CAC MEETING OF MARCH 31, 2020

4) PUBLIC COMMENT FOR ITEMS NOT ON THE AGENDA

There were no public comments.

TA Board Director Rico Medina thanked everyone for their service.

5) TRANSPORTATION AUTHORITY BOARD MEETING AGENDA FOR MAY 7, 2020

b) TA Board Item 11 (a) Approval of Shuttle Applications and Programming and Allocation of Measure A Local Shuttle Program Funds for 28 Shuttles for Fiscal Years 2021 and 2022

Peter Skinner, Director, Grants and Fund Management, presented a staff report.

Vice Chair Fox asked if the programming funds were based on the proposed plans that were discussed at the previous CAC meeting; Mr. Skinner confirmed that they were.

Vice Chair Fox said that the ridership would be depressed, which may save some money if not all the shuttles are running.

Rich Hedges said he has used multiple shuttles and said most still appear to be running. Mr. Skinner said they are all running but on a reduced schedule.

Vice Chair Fox suggested at a future meeting to discuss the restart plan for the shuttles. Joe Hurley, TA Director, said he would look into it.

c) TA Board Item 11 (b) State and Federal Legislative Update

Amy Linehan, Public Affairs Specialist, provided details on the recent federal relief funding on both known and unknown losses.

She said that the first tranche of funding includes \$28.5 million for SamTrans and \$49 million for Caltrain, adding that this money is not projected to last very long. She said the second tranche of funding will be even more critical, and that a decision by MTC (Metropolitan Transportation Commission) is expected to come in July. She added that MTC is establishing a blue ribbon committee to oversee distribution of these funds.

d) TA Board Item 11 (c) San Mateo County US 101 Express Lanes Project Quarterly Update

Leo Scott, Co-Project Manager, Gray-Bowen-Scott, provided a presentation.

Dave Reed asked about what motivated Kiewit to change their stance on allowing their workers to go back on the project. Mr. Scott said that Kiewit has a strong safety record. He said the action was done unilaterally by their management. He said that Kiewit said that they wanted to keep up the production for the benefit of their own staff.

Vice Chair Fox noted that the reduced traffic has increased the construction work window.

Mr. Hedges said he has noted people abusing the auxiliary lanes in the past.



e) TA Board Item11 (d) Update on Financing of 101 Express Lanes Project – Proposed Terms for Loan Agreement

Derek Hansel, Chief Financial Officer, provided a presentation.

Chair Arietta asked what an additional \$250,000 deposit would be applied to. Mr. Hansel said two alternatives were being proposed: Alternative 1 increases the priority guarantee from \$500,000 to \$600,000 and creates a million dollars of funding out of the bond proceeds. He said that Alternative 2 does not include the million dollars but adds an additional \$250,000 a year.

Mr. Hedges said he is concerned about a potential significant jump in interest rates if the TA does not move forward quickly enough. Mr. Hansel said that interest rates are governed by multiple factors. Mr. Hedges said they would need to raise rates to sell a large quantity of bonds.

Steven Green left the meeting at 5:45 pm.

Peter Ohtaki asked about the type of modeling and economic projections being used in deciding between a fixed and a variable interest rate.

Mr. Hansel said a decrease in economic activity is not ideal for performance, however, he expressed concern for the return of ridership when some people would prefer being in a private car over riding transit.

In response to a question by Mr. Ohtaki, Mr. Hansel discussed the pros and cons of a variable versus a fixed interest rate.

Vice Chair Fox asked about the rate on the bonds. Mr. Hansel said he agreed this was a difficult decision and that the variable rate was something to consider.

Mr. Hedges said he agreed with Vice Chair Fox about the variable rates. Vice Chair Fox suggested placing the discussion on a future meeting agenda. Mr. Hansel said they would be coming back before the Board in June or July.

f) TA Board Item 11 (e) Approval to Make an Initial Deposit to Caltrans of \$12 Million for Construction of the North Segment of the San Mateo 101 Express Lanes Project (Whipple – I-380)

Mr. Hurley presented a staff report.

She said that Caltrain had had three deaths on the tracks in the last four months. She asked if train operators have access to psychological counseling, and Mr. Hurley said yes.

Mr. Hurley noted opportunities to speed up construction projects presented by reduced traffic as a result of COVID-19. He commended the members for their attendance at the meeting during the challenging and unprecedented time.

Vice Chair Fox expressed his appreciation to staff for making the teleconference meetings possible.

Chair Arietta complimented the staff.

Mario Rendon said that the San Mateo County Board of Supervisors had approved a one-eighth-cent sales tax dedicated funding for Caltrain that morning.

Mr. Hedges said he had checked out the progress of the grade separation projects.
