## 1) CALL TO ORDER/PLEDGE OF ALLEGIANCE

Vice Chair John Fox called the meeting to order at 4:30 pm and he led the Pledge of Allegiance.

## 2) ROLL CALL

CAC Secretary Jean Brook called the roll. A quorum was present.

## 3) APPROVAL OF MINUTES OF THE TA CAC MEETING OF SEPTEMBER 29, 2020

## 4) PUBLIC COMMENT FOR ITEMS NOT ON THE AGENDA

There were no comments.

## 5) TRANSPORTATION AUTHORITY BOARD MEETING AGENDA FOR NOVEMBER 5, 2020

## a) TA Board Item 10 (a) San Mateo 101 Express Lanes Quarterly Project Update

Leo Scott, Co-Project Manager, Gray-Bowen-Scott, provided the presentation.

## Dave Reed joined the meeting at 4:53 pm

Joe Hurley, TA Director, noted that the civil project started with a much leaner contingency on a percentage basis than the toll system work. He added that they meet with the change management board weekly and are optimistic about bringing the project in within budget.



## b) TA Board Item 10 (b) Pedestrian and Bicycle Cycle 5 Call for Projects Draft Recommendations

Patrick Gilster, Manager, Programming and Monitoring, provided the presentation.

Sandra Lang asked how the need score of 12.8 was determined for the Burlingame Caltrain Station. Mr. Gilster said that the reviewers look at factors such as population and employment density and access to activity centers.

#### Public Comment:

Kelly Moran, President, Bay Meadows Neighborhood Alliance, said that the Alliance opposed funding the project until the bicycle portion of it could be re-scoped.

Chair Arietta expressed her concern for blind intersections in such a high-density area. Peter Skinner, Director, Grants and Fund Programming, said that the TA has an open offer to facilitate a meeting with the community regarding safety issues.

Vice Chair Fox said that a project that restricts counter-flow would not pass design guidelines.

Peter Ohtaki asked why the Menlo Park Middle Avenue bike/ped underpass was not granted its full funding request. He said that when he was a member of the Menlo Park City Council, he had struggled to request funding contributions from Stanford University for the project. Mr. Gilster said that the Evaluation Committee said that there is currently a \$10 million funding gap with this project. He said that they could come back in the next cycle.

Rich Hedges asked how the project complements the Burlingame bike lanes that had been funded in the previous cycle. Mr. Gilster said that the part north of the roundabout helps to fill the gap toward Millbrae.

Dave Reed noted there were no calls for projects on the Coastside and asked how to promote Coastside projects. Mr. Gilster talked about the recent Half Moon Bay project.

#### Steven Green left the meeting at 5:35 pm

Naomi Hsu suggested funding the El Camino Real crosswalk without funding the part of the project that would route bicyclists to the north side of 28<sup>th</sup> Avenue.

Jeff Londer said he shared the other members' safety concerns for the 28<sup>th</sup> Avenue crossing.

Ken Chin noted that there was time to provide input to the recommendations before final approval by the Board in December. He advocated moving ahead with the planning project and suggested that improvements for pedestrians/bicycles should be made at the Caltrain station driveway.

Sue-Ellen Atkinson, Principal Transportation Planner, City of San Mateo, noted that they had brought the concerns of the Bay Meadows neighborhood to the Caltrain project team and started working with them to mitigate issues and explore, develop, and evaluate modifications and improvements.



Vice Chair Fox summarized the CAC members' concerns about the project. He said the design team needs to look at all the proposed projects together from a safety standpoint.

Mr. Hedges noted that the original traffic studies for the 28<sup>th</sup> Avenue project indicated that it would serve the neighborhoods on the west side of El Camino Real.

## c) TA Board Item 11 (a) Programming and Allocation of Measure A Transit -- Caltrain Category Funds to Support the Atherton Station Closure Project

Mr. Skinner introduced David Pape, Principal Planner, who provided the presentation.

Mr. Chin asked how much of the estimate was related to the quad (four-quadrant) gates. Mr. Pape said \$5 million.

Vice Chair Fox said the quad gates are required for high-speed rail and improved safety and asked why funding is not available through another source to build them. He asked why the TA was taking the expenditure out of Measure A instead of out of some other mechanism that pays for gates and improvements along the high-speed rail and Caltrain corridor. Mr. Skinner said the state local partnership program may fund half the cost of the quad gate construction pending the CTC's (California Transportation Commission) decision. He said they are also seeking federal funding from the Section 130 program.

Mr. Chin asked if installation of the quad gates qualifies the crossing as a quiet zone. Mr. Skinner confirmed that it was one of the prerequisites for applying to the Federal Railroad Administration to become a quiet zone

Mr. Hedges noted that public comment from Atherton supported the closure.

Vice Chair Fox asked about the cost estimate to rebuild Atherton Station. Sebastian Petty, Director, Caltrain Policy Development, said \$30 million.

Mr. Ohtaki said that he supported the station closure but said he thought that an alternative funding mechanism would be a win-win for everyone concerned.

Mr. Reed said that the City of San Leandro had spent under \$3 million to install a quad gate in 2018.

Mr. Ohtaki said there was only a \$500,00 difference between the first guarter of Fiscal Year 2021 versus the actual for the previous fiscal year.

Connie Mobley-Ritter, Director of Treasury, said they do not yet have the actual sales tax numbers, so it is too early to predict the County sales tax revenues. She said they would report back to the CAC with actuals in December.

Mr. Hedges said he appreciated that Mr. Reed had checked the price of the quad gates. He questioned why the cost would increase 60 percent in a two-year period. He said that MTC (Metropolitan Transportation Commission) is doing an equity study on express lane tolling. Mr. Hurley noted that the San Mateo County Express Lanes JPA (Joint Powers Authority) had embarked an equity study as well.

Vice Chair Fox encouraged the CAC members to share their thoughts about the ranking of the bike/ped projects with Mr. Gilster.
