I was in the Brooklyn Navy Yard, Fall 65 - Winter 66. USS Duluth LPD-6 was final ship built in the Brooklyn yard.

I was in Norfolk when the lights went out earlier in the Fall.

You can hire John Kagel in Palo Alto as an arbitrator. John charges \$3500 / day minimum.

Sam Kagel was the ILWU / PMA coast arbitrator for 40 years.

I met his Mom at ILWU Bloody Thursday in 2007. It was the year that Sam passed away. I took Mom to her last Bloody Thursday event July 5, 2008.

This might be an economic way to arbitrate the strike.
