Draft Governance Recommendation for Discussion - Draft Governance Recommendation for Discussion - staff provided a straw proposal regarding Caltrain Governance, trying to incorporate into the proposal the divergent perspectives heard throughout the year. Board members provided feedback to staff. While the Board generally agreed that the proposal

was constructive and had some encouraging attributes, some Board members requested additional refinement. Board member comments included providing more clarity on the proposed agreements, interest repayment calculations for the repayment to SamTrans for the Purchase of the Caltrain Right of way, the role of the auditor, the executive director reporting structure, and taking a leadership role in regional rail discussions.
